# Association of British Members OF THE Swiss Alpine Club.

---

## RULES.

---

### 1. NAME.

The name of the Association shall be "The Association of British Members of the Swiss Alpine Club."

### 2. OBJECTS.

- (a) To encourage British Alpinists to support the Swiss Alpine Club in all its work, by becoming members of a section of that body.
- (b) To collect funds and present to the S.A.C. a club hut, and for such other purposes as the Association may from time to time determine.
- (c) To form a body able to present a collective opinion to the S.A.C. on any question of Alpine interest.
- (d) To promote among British members the sociability which is so conspicuous a feature of the Swiss sections, but from which we are necessarily debarred by living at a distance from the headquarters of our sections. This is done by informal Dinners, Lectures, Smoking at Homes, and Showing Alpine Slides on the Lantern.

### 3. CONSTITUTION.

- (a) **Officers.**—President,  
Vice-Presidents,  
Two Hon. Secretaries,  
Hon. Treasurer,  
Hon. Auditor, } To be elected annually  
in December.

**Members.**—1. Ordinary. The qualification for ordinary membership shall be "membership of some section of the S.A.C."  
2. Honorary. To be elected at the discretion of the Committee.

#### 4. SUBSCRIPTION.

The Annual Subscription to the Association shall be 5/- per annum, payable at election. The payment of  $\text{₹}2$  2s. shall be considered as equivalent to the annual payment of 5/-.

Annual subscriptions shall be due on 1st January of each year, and any member whose subscription shall not have been paid on or before 1st April shall cease to be a member of the Association, but may be reinstated on payment of arrears, at the discretion of the Committee. Any member joining after the 1st November shall not be required to pay his subscription for the ensuing year.

#### 5. GENERAL MEETINGS.

There shall be at least two General Meetings in the year, viz., The Annual General Meeting and a dinner in December, a more informal meeting in June, and such winter meetings as the Committee may think fit.

#### 6. POWERS OF THE COMMITTEE.

- (a) The Committee may by a two-third majority of those present, call upon any member to resign if they consider his conduct to be incompatible with Membership of the Association, but such member shall have the right of appeal to the next general, or special general meeting, which shall have the power of confirming, or annulling, by a two-third majority, the decision of the Committee.
- (b) The Committee, on the requisition of 12 members, may call, at any time, a Special General Meeting, provided that *seven* clear days' notice shall be given to all members of such a Special General Meeting, together with full information as to the place, time and business to be transacted.
- (c) The Committee shall have the power to submit any new proposal affecting the Association to a General or Special General Meeting of the members of the Association.

#### 7. COMMITTEE.

The Committee shall consist of ex-officio members and ordinary members.

- (a) The Ex-officio members shall be the officers of the Association for the time being.
- (b) The ordinary members of the Committee shall be 12 in number; and shall be elected at the Annual Meeting of the Association; one-third of these shall retire annually and shall only be eligible for re-election after one year has elapsed. The Committee may co-opt not more than three additional members, one of whom must retire yearly; the mode of election and the manner of re-

tirement to rest with the Committee. Five members shall constitute a quorum.

The Committee may suggest names for Officers and Committee, but this is not to be taken as precluding any two members from nominating candidates, whose consent, however, must be previously obtained.

At least three weeks' notice of the Annual Meeting shall be given to every member; and nominations for officers and Committee must be sent in to the secretaries at least ten days before the Annual Meeting. In the event of more candidates being nominated than there are vacancies the election shall be by ballot.

#### **8. ACCOUNTS.**

The accounts of the Association shall be audited in January and presented by the Treasurer at the next General Meeting of the Club, and shall be published with the Annual Report.

#### **9. CASUAL VACANCIES.**

The Committee shall have power to fill up casual vacancies amongst the Officers or Committee; and those chosen shall serve for the unexpired period of office to which the member whom they succeed was entitled.

#### **10. ROOM FOR MEETINGS.**

The Committee shall have power to hire premises for the purposes of the Association.

#### **11. AN ANNUAL REVIEW.**

The Committee shall have power to publish an Annual Review and appoint an Editor when they think the funds of the Club will permit.

#### **12. ALTERATION OF RULES.**

A General Meeting shall have power, by a majority of not less than two-thirds of the members present and voting to alter or add to the existing rules of the Club.

#### **13. REGULATIONS.**

The Committee shall have power to make such regulations, not being inconsistent with these rules, as they think to be for the well-being of the Club.

#### **14. THE CHAIRMAN.**

The Chairman whether at a General Meeting or at a Meeting of the Committee shall in case of an equality of votes have a second or casting vote.

## SWISS ALPINE CLUB.

---

Anyone wishing to become a member of the above, should apply to the Treasurer of the Association of British Members of the S.A.C. He should state whether he wishes to join a French or German speaking section. The subscription varies slightly in different sections. It is usually 14/- a year, and 8/- entrance fee. Members obtain reductions on certain Swiss railways (e.g., half-price on Zermatt Railway), a right of entry at the Club Huts, instead of being there on sufferance, a monthly magazine in French, *or* the Jahrbuch in German, etc. If, in addition, he wishes to belong to our Association in England, the extra subscription is only 5s. a year, or £2 2s. for life.

The Central Committee of the Swiss Alpine Club have cordially approved of the formation of our Society, and the large majority of British members have joined our Association.

### HOW TO BELONG TO SWISS ALPINE CLUB.

Those who do not yet belong to the Swiss Alpine Club and desire to do so, can be put up at once, even if they do not wish to belong to our Association. They should write to the Treasurer, J. A. B. Bruce, Selborne Lodge, Guildford, and state whether they wish to join a French, German, or Italian speaking section. The subscription varies slightly in the various sections, *e.g.* in Geneva 17½ francs a year (14/-), and 10 francs (8/-), entrance fee. The Association can arrange to pay the subscriptions to the S.A.C. yearly, or will supply Bankers Forms for that purpose. If 22/- (the first year's subscription and entrance fee) is sent the candidate can be elected at once. If he wishes to obtain the full advantage of membership he should also enclose a small photograph of himself, this will be endorsed by the Treasurer of the section and returned on his card of membership. If, in addition, he wishes to belong to our Association in England, the subscription is only 5/- a year, or £2 2s. for life.

### ADVANTAGES OF BELONGING TO THE SWISS ALPINE CLUB.

Members of the Club obtain reductions certain Swiss Railway (*e.g.*, half-price on Zermatt Railway); half-price at certain Huts; a RIGHT of entry at the Club Huts, instead of being there on SUFFERANCE; a fortnightly paper and monthly magazine in a French section free; the Jahrbüch, a well-illustrated Annual, half-price 6 francs, and other advantages. In a German speaking section the Jahrbüch is compulsory and included in minimum subscription, but the Echo des Alpes is extra.

A good feeling is created amongst the Swiss when they see British climbers, who use their Huts, contributing to their support by becoming members of the S.A.C.

Club Hut Album contains pictures of all the S.A.C. Huts, and descriptions, it is issued as a supplement to Jahrbüch.

### INSURANCE OF GUIDES.

The S.A.C. contributes one half the cost of insurance, if the guide pays the other half.

**HONORARY MEMBER.**

The Bishop of Bristol who was an ordinary member of our Association has been elected an honorary member during the year.

**SWISS ALPINE CLUB.**

We have proposed about 70 new members for various sections of the S.A.C. during the year. The British members now number nearly 480, of whom the large majority have been proposed through and since joined our Association.



### **CLUB HUT "BRITANNIA."**

We collected £830:1:6 for this fund, and 20,123 francs has been sent to the C.C. of S.A.C., and will be handed to the Geneva section, who undertook the erection of the Club Hut. The Club Hut "Britannia" was opened on August 17th, 1912. An account of the inauguration with illustrations will be presented to our members and to the subscribers. A large model of the Hut has been presented to the Association by the Geneva section.

### **OUR LATE PRESIDENT—CLINTON DENT.**

The Committee passed a resolution on your behalf expressing their sense of the deep loss we have sustained in the death of our late President, and conveyed to the members of his family an expression of their heart-felt sympathy.

### **MEMORIAL TO OUR LATE PRESIDENT.**

The Committee after consultation with several of the friends of the late President recommended that a memorial be erected at Zermatt and at the Cabane "Britannia." The Geneva section have given their consent to this latter proposal, and a Sub-committee has been appointed to carry it out. Mr. E. Dent, the brother of our late President has kindly presented us with Mr. C. Dent's portrait.

### **OUR NEW PRESIDENT.**

The Committee elected Mr. A. E. W. Mason, as President, and are glad to say he has accepted that position and took the chair at our Annual Meeting and Dinner on December, 3rd.

### **THE COMMITTEE.**

The following retired from the Committee in accordance with the Rules: Dr. H. L. P. Dent, H. G. Pulling, A. N. Andrews, H. Hutchinson, W. M. Roberts, R. C. Richards, The following have been elected in their place. J. Y. Dent, G. Dimier, W. Larden, G. Steel, C. Hartree and E. D. Murray.

### **HON. TREASURER.**

Mr. King-Church has resigned his post as Hon. Treasurer, and a cordial vote of thanks was passed to him for his services. Mr. J. A. B. Bruce has been elected in his place.

**HON. SECRETARIES.**

Mr. J. A. B. Bruce resigned his post as Hon. Sec., and Mr. A. N. Andrews has been elected; Mr. E. B. Harris continues in office.

**FINANCE.**

The accounts of Receipts and Payments and Balance Sheet are annexed and will be presented after audit at the next General Meeting. After transferring £177 17s. to the Life Membership Account, as agreed, there is a balance in hand of £5 15s. 9d.

**MEETINGS AND DINNERS.**

May 8th.—Informal Dinner at the Blenheim Restaurant.

Lantern slides shown afterwards at the Alpine Club by C. Dent, on Alps and Caucasus; E. C. Richardson, on Ski Running; Dr. Ellwood, on Glaciers; J. Bruce, on Site of Club Hut.

June 24th.—Annual Summer Dinner at the Blenheim Restaurant.

Afterwards Professor Roget spoke and slides were shown at Alpine Club Gallery.

August 17th.—Inauguration of "Cabane Britannia" on Kleine Allalinhorn.

Dinner in evening at Dom Hotel, Saas Fee, 120 present, half of whom were English.

October 29th.—Informal Dinner at Blenheim Restaurant.

Slides were shown after at the Alpine Club, about 150 attended including ladies.

December 3rd.—Annual Meeting followed by Annual Dinner, at the Holborn Restaurant, about 90 attended.

Mr. A. E. W. Mason in the chair. After the toast of the King, Queen and Royal Family, the President proposed the memory of our late President, this was drunk in silence and responded to by Mr. Douglas W. Freshfield. Mr. Edward Dent, brother of the late President, thanked the members for their appreciation of his late brother.

The toast of the S.A.C. was proposed by the President,

and responded to by Mr. G. Dimier, in the absence of the Swiss Minister. The Alpine Club and kindred Associations was proposed by Mr. E. Foa and responded to by Mr. H. E. M. Stutfield. The Visitors were proposed by Mr. H. G. Pulling and responded to by the Right Hon. Sir S. Evans (President of the Probate and Divorce Court), Sir E. T. Cook and Professor Farmer. The officers of the Society were proposed by Mr. George Radford, M.P., and responded to by Mr. J. A. B. Bruce and Mr. Harris, the Hon. Secs., who proposed a vote of thanks to Mr. A. E. W. Mason, for taking the Chair. The Committee have decided to discontinue publishing the speeches made at the dinner.

A vote of thanks to the Alpine Club for allowing us the use of their gallery was in each case passed.

#### CLUB ROOMS.

The Committee of the Association have been in negotiation with other Clubs of a similar nature to secure a room or rooms which would afford a meeting place for members, and the establishment of a small Alpine Library. The Geneva section, which numbers 230 English members (out of a total of a thousand) have promised to pay part of the cost, so that their members in England may obtain out of their own subscriptions some of the advantages which their Swiss colleagues possess, but from which we are debarred by living in England. The exact amount will be fixed by them on January 15th. Other sections have promised to consider the question.

#### MR. LARDEN'S BOOK, "CHALET INSCRIPTIONS IN SWITZERLAND."

This book is being published by subscription. About 150 promises have been received. Mr. Larden is willing to publish it if 200 promises are sent in. The price will be 10/6, and as the work is of great literary value the committee hope members will assist by sending in their names to Mr. Larden, 22, Wellington Square; Oxford.
